

Get WarmWise Giveaway Rules

Official Rules

1. NO PURCHASE FROM COLUMBIA GAS OF VIRGINIA'S WARMWISE PROGRAM NECESSARY OR CHARGE REQUIRED TO ENTER OR WIN.
2. Promotion Period. This promotion (the "Promotion") begins at 12:01:01 AM ET on Sept. 26, 2011 and ends at 11:59:59 PM ET on Nov. 27, 2011 (the "Promotion Period").
3. Eligibility. This Promotion is open to individuals that are at time of entry 18 years of age or older and legal residents of the State of Virginia that are currently Columbia Gas of Virginia Inc. ("CGV") residential customers taking service under the rate schedules RS or RTS (as defined in CGV's Gas Tariff on file with the Virginia State Corporation Commission) and that complete their own Home Savings Evaluation survey during promotion period and/or complete and receive CGV approval on a WarmWise rebate through the WarmWise Home Savings Program. This Promotion is void in all locations other than the State of Virginia. Employees, officers, directors, representatives, and agents, of CGV or its corporate parent, subsidiary, corporate affiliates, or advertising or promotional agencies ("Related Entities") and their immediate families (spouse, children, parents, and siblings) and those living in the same household of such persons at any time during the Promotion Period are not eligible to participate. The rebate application must be approved by CGV before entry to the Promotion is granted.

Once you have completed the applicable Home Savings Evaluation survey and/or been approved for a rebate application, your name will automatically be entered in the sweepstakes, unless you opt-out of entry. All registrations must be completed and entries received by 11:59:59 PM ET on Nov. 27, 2011. This Promotion is limited to one entry per household per qualifying action.
