Official Rules

Please read these Official Rules (these "**Official Rules**") of Columbia Gas of Virginia, Inc.'s 25080007 August 2025 WarmWise \$200 Promo (the "**Sweepstakes**"). You must agree to accept and comply with these Official Rules to participate in the Sweepstakes.

- 1. SPONSOR. Columbia Gas of Virginia, Inc., a Virginia corporation (the "Sponsor" or "Columbia Gas"), with a principal business address of 1809 Coyote Drive, Chester, VA 23836.
- 2. Who Can Enter? The Sweepstakes is open to you only if you satisfy the following requirements: at both the time that you enter the Sweepstakes and at the time the prize is awarded, you must be at least 18 years of age, a legal resident of the Commonwealth of Virginia, and reside in Columbia Gas of Virginia's Service Territory. - **4. How to Enter?** There are 2 ways to enter the Sweepstakes: (a) participating in Columbia Gas of Virginia's August 2025 WarmWise \$200 Promo; and (b) a mail-in method.
 - a. Participating in Columbia Gas of Virginia's August 2025 WarmWise \$200 Promo Method.
 - i. You may enter the Sweepstakes by completing an online Home Savings Evaluation at http://www.columbiagasva.com/free; OR updating your online profile if a Home Savings Evaluation has previously been completed; OR you may enter the Sweepstakes by purchasing any product from the online store at https://columbiagasvastore.com/; OR you may enter the Sweepstakes by purchasing and installing qualifying furnaces or boilers, smart thermostats, water heaters, clothes gas dryers, direct vent fireplaces, windows, skylights or doors, submitting the rebate application and receiving approval by Columbia Gas of Virginia.  - ii. An entry pursuant to this Paragraph 4(a) will be deemed valid and eligible for consideration only if such entry is received by the Sponsor during the Sweepstakes Period.
 - iii. All Internet access and usage charges are your sole responsibility.
 - iv. The Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, any Sweepstakes entries submitted pursuant to this Paragraph 4(a). The Sponsor is not responsible for any problems or technical malfunctions of any telephone network or lines, computer on-line systems, servers or providers, computer equipment, software, failure of any e-mail or entry to be received by the Sponsor on account of technical problems or traffic congestions on the Internet or at any website, or any combination thereof, including any injury or damage to your or any other person's computer-related to or resulting from participation or downloading any materials in the Sweepstakes. Any such entries shall be deemed invalid and ineligible for purposes of the Sweepstakes.
 - v. Entries generated by robots or scripts or other automated devices will be deemed to be a direct violation of these Official Rules, and any such entries shall be deemed invalid and ineligible for purposes of the Sweepstakes.

b. Mail-In Method.

- i. As an alternative to the method of entry described in Paragraph 4(a) above, you may enter the Sweepstakes by printing your name, age, complete street/mailing address (including zip code), phone number (including area code) on a 3½" x 5" card and mailing the completed card, with sufficient first-class postage affixed, to Columbia Gas of Virginia, ATTN: 25080007 August 2025 WarmWise \$200 Promo, 1809 Coyote Drive, Chester, VA 23836. Such mail-in entries for the Sweepstakes must be legible, and submitted in original hand-printed form. A mail-in entry pursuant to this Paragraph 4(b) will be deemed valid and eligible for consideration only if such entry is received by the Sponsor during the Sweepstakes Period.
- ii. The Sponsor is not responsible for any lost, late, misdirected, postage due, damaged, mutilated, illegible, indecipherable, incomplete, inaccurate or deceptive Sweepstakes entries, all of which entries shall be deemed invalid and ineligible for purposes of the Sweepstakes.
- **5. How Many Times May You Enter?** Only ONE ENTRY per participant is permitted during the Sweepstakes Period. In the event that more than one entry is received with respect to any participant, the first entry processed by the Sponsor will be considered the only valid entry.
- **6. What is the Prize?** There will be ONE prize awarded in the Sweepstakes pursuant to the procedure described in Paragraph 7. The Prize Recipient will receive a gift card in the amount of Two Hundred Dollars, \$200.00 (the "Prize"). The Prize is not transferable or assignable.
- 7. How is the Prize Recipient Determined? During the Sweepstakes Period, eligible Sweepstakes entries received online pursuant to Paragraph 4(a) will be combined with the eligible mail-in Sweepstakes entries received by the Sponsor pursuant to Paragraph 4(b), in order to create the entry pool for the Sweepstakes (the "Entry Pool"). On September 22, 2025, or on some other date (as determined by the Sponsor in its sole discretion) (the "Prize Drawing Date") following the conclusion of the Sweepstakes Period, the potential recipient of the Prize (the "Prize Recipient") will be selected by means of a random drawing conducted by the Sponsor from among all eligible entries contained in the Entry Pool. All decisions of the Sponsor regarding the Prize drawing and any and all other aspects of the Sweepstakes shall be final, binding and non-appealable. Your odds of receiving the Prize (or any other prize awarded hereunder) will be determined by the total number of eligible Sweepstakes entries. Such odds are equal regardless of the method of entry used to enter the Sweepstakes.
- 8. How is the Prize Recipient Notified? Shortly after the Prize drawing described in Paragraph 7, the Sponsor shall endeavor to notify the Prize Recipient by telephone or U.S. mail, email or by other reasonable means. If you are the Prize Recipient, you may be required to complete, sign and return an affidavit in accordance with these Official Rules. If the Prize Recipient fails to respond to the Sponsor within 5 days after being notified by the Sponsor, or if such notification or the Prize itself is returned as undelivered, or if an affidavit is required but not timely returned, then at Sponsor's sole discretion, the Prize Recipient may be deemed to have forfeited any and all rights to receive the Prize, and the Sponsor may elect to (but shall not be required to) select an alternate Prize Recipient by means of another random drawing pursuant to the procedure described in Paragraph 7 from among the remaining eligible Sweepstakes entries. The Prize Recipient should allow 2 to 4 weeks after timely responding to Sponsor to receive the Prize.
- 9. How Can I Find Out Who Won the Prize? - 11. Proof of Identity and Affidavit. To the fullest extent consistent with applicable law, the Prize Recipient hereby specifically grants permission to Sponsor to use his/her name, city, state, photograph, likeness (actual or simulated) and/or voice for any and all advertising, marketing, promotional, publicity or other legitimate commercial purposes, including, without limitation, providing his/her name to any person who requests such name pursuant to Paragraph 9 of these Official Rules, without any obligation on the part of Sponsor (a) to pay any additional compensation (of any kind or amount) to such Prize Recipient, or (b) to seek or obtain the approval of such Prize Recipient.
- 13. Agreement to the Official Rules. By participating in the Sweepstakes, you fully and unconditionally agree to accept these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes.
- **14. Governing Law**. These Official Rules and any disputes relating thereto are governed by and shall be construed in accordance with the laws of the State of Virginia, without giving effect to any choice or conflict of law provision or rule that would cause the application of the laws of any other jurisdiction other than the laws of the State of Virginia. THE SWEEPSTAKES ARE VOID WHEREVER PROHIBITED BY LAW.
- **15. Release**. You hereby release the Sponsor, its parent companies, subsidiaries and other affiliates, and their respective directors, officers, managers, members, partners, agents, employees and representatives from any and all claims, costs, injuries, losses or damages of any kind caused by your participation in the Sweepstakes or acceptance or use of the Prize.
- **16. Taxes**. All federal, state, and other tax liabilities arising from the Sweepstakes are the sole responsibility of the Prize Recipient. If applicable, a Form 1099 will be sent to the Prize Recipient.
- 17. Disputes and Waiver of Damages. You expressly agree, irrevocably and in perpetuity, that: (a) any and all disputes, claims, actions and causes of actions arising out of or in connection with the Sweepstakes, any Sweepstakes related activity, or any Prize awarded hereunder, shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall be brought and shall take place exclusively in a federal or state court located in the State of Virginia, and your participation in the Sweepstakes is your agreement to submit to the exclusive jurisdiction and venue of such courts; (b) any and all claims, judgments, damages, and awards shall be limited strictly to actual out-of-pocket costs actually incurred by you and paid to a third party, including costs associated with entering the Sweepstakes, but excluding attorneys' fees; and (c) under no circumstances shall you be permitted to obtain awards for, and you hereby waive any and all rights to claim, punitive, exemplary, special, consequential, incidental, indirect and/or other damages, other than for actual out-of-pocket expenses actually incurred by you and paid to a third party.
